Foundation Match Offers Double Donations

While the Foundation's big news is awarding \$1 million in Community Grants outside the gate this year, that's not the end of the good news or the funding that will come from the Greater Ocean Reef Community. Following our annual grants announcements, we've traditionally invited our Donor Advised Funds to co-invest in charitable projects we were not able to fully fund. Our Co-Investment Opportunities, as we call them, have resulted in hundreds of thousands of dollars for local charities in addition to our grants and enabled private Ocean Reef donors to combine efforts to have a greater impact. We'll share the "opportunities" with the whole membership for the first time here.

This year we're offering two matching grants, which means the charity must raise half of the total request from other sources to receive our funding. It also means the Foundation will match your contributions dollar for dollar up to \$25,000 to Habitat for Humanity and \$23,100 to the United Way for specific Upper Keys projects. Match challenges are meant to help charities broaden their support.

The Habitat match grant will go toward building a seventh and final reasonably-priced family home with a no-interest mortgage in Key Largo's Mandalay community on county-donated land. The Foundation has long recognized the critical lack of affordable housing that is driving Conch (local) families out of the Kevs and contributed to each of the houses in Mandalay -- along with homeowners and many volunteers, local contractors and businesses -- over the years.

The United Way match project is a new one, developed in response to the high cost of living in Monroe County, which is 44% higher than the nationwide averages used to determine eligibility for assistance programs. The proposed Success by Six program was created to help working families with incomes considered too high to qualify for assistance with childcare costs for preschoolers. but which the United Way's ALICE (Assets Limited, Income Constrained, Employed) Report determine to be poverty level based on the area's actual cost of living. The grant will provide scholarships to help bridge the

gap.

More than 40 projects were fully funded this year, but our Co-Investment Opportunities include almost 20 projects the Community Grants program was only able to partially fund, as well as four programs initiated by the Foundation to meet community needs. Each charity included has been fully vetted by a Grants Committee of your peers and qualified for Foundation funding.
